- **1. National Anthem** The singing of O'Canada was led by Claire Driscoll, accompanied by Robert McKinney.
- 2. Call to Order— Mayor Driscoll welcomed those in attendance to the 12th Annual Mayor's Levee. He thanked His Honour Wallace Turnbull, Reverend Doctor John Crawford and Clair Driscoll for their participation in the ceremony.

December 2013 Ice Storm/Power Outage - Mayor Driscoll also acknowledged the resilience and tenacity of the community in its response to the past week's ice storm and massive power outage in the Kennebecasis Valley and throughout many parts of New Brunswick. He gave special recognition to Brian Shanks, EMO Director, and all others who assisted the Town in the operation of the Warming Centre that remained open for eight straight days during the power outage to help those in need.

Mayor Driscoll also paid special tribute to his soon to be 98 year old mother-inlaw, Dorothy MacMurray, who braved the cold weather to attend this ceremony. He turned the meeting over to Deputy Mayor O'Hara to MC the Presentation of the Chain of Office Ceremony.

- 3. Deputy Mayor O'Hara, MC Deputy Mayor O'Hara welcomed and introduced Council and Staff to those in attendance. She acknowledged other dignitaries in attendance such as Hampton's MLA, Bev Harrison, Police Chief Steve McIntyre, Mr. Kwon Young, President of the Korean Community, EMO Director, Brian Shanks, and Participants The Honourable Wallace S. Turnbull, QC; The Reverend Doctor John Crawford, and Councillor Emil T. Olsen.
- 4. Councillor Emil T. Olsen Reading of the History of a Chain of Office Councillor Olsen acknowledged the Canadian Heraldic Authority granted Quispamsis its official Armorial Bearings the Coat of Arms and Flag in May, 2008. As the final phase of that process, the Town has developed a Chain of Office, which acknowledges the responsibilities, authority and dignity which are attached to the Office of the Chief Magistrate of the Town. He noted the practice of wearing a Chain of Office originated over a thousand years ago, with civic authorities bearing their official seal incorporating the arms of the authority. Today, mayors of municipal councils throughout the democratic world wear distinctive chains of office, symbolic of their communities. Quispamsis' Chain of Office includes the Town's Coat of Arms as the suspended medallion, name bars for each of the Mayors who have served the community, the Provincial flower, the Provincial Coat of Arms and Metal Maple leaves representing Canada.
- **5. The Reverend Doctor John Crawford** The Reverend Doctor John Crawford led a benediction to dedicate the Chain of Office.
