2.1 <u>Hurricane Arthur</u> - Mayor Driscoll thanked everyone who had helped out in the aftermath of Hurricane Arthur, noting the Town had operated a Charging Centre for those without power to charge their mobile devices and fill their water containers, etc. He thanked Staff, Red Cross Workers, Cooke Agriculture and the Superstore for their contributions to those in need. In addition, he noted Quispamsis residents can take brush from post-Tropical Storm Arthur to Renforth Construction, located at 91 Palmer Brook Road, with coupons available at town hall for proof of residency and redeemed no

later than July 19. Smaller brush can be composted through home owner's private waste-removal provider.

#### 8. Unfinished Business

- 8.1. (May 6/14) Pettingill Road Quispamsis Road Traffic Review (David Down's Request for Safety Improvements) A Staff Report from Mr. Losier stated the Town has engaged the services of exp Services to do a Traffic and Intersection Review of the Pettingill Road/Quispamsis Road intersection taking into account current conditions and traffic associated with the future opening of the Francophone and Anglophone Schools, plus the potential Subdivision across the street. The review included traffic volume analysis, intersection geometry review, recommended school zone safety review, school bus turning movement analysis and general intersection safety impacts. The Consultants concluded the various new developments near this intersection are expected to increase the traffic volumes significantly at this location, and recommended the following improvements be made:
  - Convert the intersection to an All Way Stop; (phase in to coincide with school opening);

- Relocate stop bars to accommodate turning movements;
- Realign a portion of curb in front of the Church property to allow desirable lane widths:
- Install sidewalk on West side of Quispamsis Road, (in front of School) from Pettingill to School main entrance;
- Evaluate requirement for improved or increased lighting in area.

The Town commence the necessary action and Bylaw changes to phase in the conversion of the existing intersection to an all-way stop. In addition, the town will identify any costs associated with recommended safety concerns for referral to the Province for inclusion in their overall project completion. Further, Mr. David Downs who made prior presentation to Council on this matter be informed of the recommended action.

8.2. (June 17/14) Fundy Wellness Network - Request for Financial Support - A Staff Report from the Director of Community Services indicated Quispamsis has been a valued and active member of the Fundy Wellness Network for the past three years, noting the Town has hosted FWN meetings at the qplex as well as the Wellness Conference last fall. Staff have offered the qplex at no charge for the Wellness Conference this year, in lieu of the \$500 donation request, but the offer was turned down as they have already been given the use of the HMCS Brunswicker as this year's venue for the Conference.

# 9. Correspondence

9.1. KV Girls Softball Association Inc. – Kelly Lynch, President, Hosting the Under 14

Eastern Canadian Fastpitch Softball Championships August 21 - 24, 2014

Request to Waive Ballfield Rental Fees (\$950) - In Attendance: Stacy Blois, KV Girls Softball Vice-President & Kelly Wear, Eastern Canadians Tournament Director

The KV Girls Softball Association. representatives expanded upon Ms. Lynch's correspondence informing Council they have been successful in winning the bid to host the Under 14 Eastern Canadian Fastpitch Softball Championships August 21 – 24. The tournament will bring 12 teams from Ontario, Quebec, NB, NS, PEI and Newfound to the community. They noted the high cost associated with hosting such a large event and asked Council for its support by waiving the ball field rental fees during the tournament.

Council members expressed concern of setting a precedent by waiving rental fees for recreational facilities, noting there are several tournaments hosted throughout the year by various groups, and these fees help offset maintenance costs of the facilities.

9.2. Request for Block Party – Pelly Court – August 9th, 2014 – Lori Richard & Lilli Ju Lin – Correspondence to Council requested permission to host a block party for the residents of Pelly Court, Fireweed Drive and Bonanza Drive on August 11, 2014. All residents of Pelly Court are in support of using the court for the party, and they will deliver notices with details of the event to residents of Pelly Court, Fireweed Drive and Bonanza Drive. The party will include games for the kids and families, a BBQ/potluck and light entertainment.

A Staff Report from the Municipal Planning Officer recommended approval by granted subject to certain conditions, including that proper notification be given to Emergency Services.

- All residents of Pelly Court to submit to the Town written approval of the request; and
- Fireworks to be completed no later than 10:00pm. (Noted subsequent approval of the Fire Marshall or Fire Chief also required)

Rothesay Netherwood School, Paul Kitchen, Head of School - Proposed Renovations to RNS Arena - Request for Support, in Principle, (Draft Support Letter from Mr. Kitchen) - Mr. Kitchen's letter informed Council RNS is hoping to have the Town's support in seeking funds to assist in the renovation of the RNS Memorial Arena, built in 1950 and upgraded in 1996. The project will include the

addition of dressing rooms for a cost of approximately \$750,000. Mr. Kitchen noted the addition will provide KV Minor Hockey with increased ice time.
