ICE HELMET POLICY

CSA approved protective helmets are mandatory for <u>all</u> individuals, at <u>all</u> times, while on the ice at Town of Quispamsis arenas. Failure to wear a helmet will result in the removal of the individual from the ice surface until they are wearing an approved helmet.
