# 5.2 <u>Victoria Clark, Executive Director of Discover Saint John, - Canada 55+ Games Awarded the CSTA 2019 Prestige Award for Sports Event of the Year (Under \$1m Budget)</u>

Ms. Victoria Clark informed those in attendance that Discover Saint John is a private public partnership between the City of Saint John and the City's Hotel Association. She announced the 2018 Canada 55+ Games event was this year's recipient of the CSTA, (Canadian Sport Tourism Alliance), Canadian Sport Event of the Year Award for Canada. The event, co-hosted by the City of Saint John and the Town of Quispamsis last August, celebrated healthy living in those aged 55 plus, brought in 2300 participants plus their family members to the Saint John region, and inspired many to compete provincially and nationally at future events. The event leveraged over 500 volunteers who gave thousands of hours, including co-chair, Councillor Emil Olsen, and Honorary Chair, Scott McCain. In addition, co-Chair, Ms. Barb Curry, was nominated as a finalist in the Volunteer of the Year Award category.

Ms. Clark stated sport tourism is the fastest growing segment of the tourism industry in Canada with over \$6.8 billion in annual spending by domestic and international visitors.

- 9. Correspondence
  - 9.1 <u>Gary Martin, Spokesperson, Cedar Ridge Boulevard Petition Flooding Issues</u> between Deer Path Court and Hampton Road

Mr. Martin read the petition, signed by 19 Cedar Ridge Boulevard residents, indicating 10 of these residents have had their basements flooded on at least one occasion during the three winter mega rain/snow storms of 2019. Mr. Martin stated it is his understanding that the Town is responsible for the maintenance of the 33 foot municipal right of way from the centre of the road to the property line, which includes ditches and culverts. When the Town has cleared the culverts and ditches from Deer Path Court to Lyman Street, there is not an issue, however when these ditches and culverts become plugged with compacted snow and ice, flooding occurs as there is no natural movement of storm water.

The residents, Mr. Martin said, are requesting in the short term a standing work order for the Town Work Crew's to attend to clearing the culverts/ditches in their area a day or two before a predicted storm of rain magnitude; and as a long term solution, installation of a storm sewer with catch basins before any road resurfacing is applied from Deer Path Court to Hampton Road, hopefully this year, or if not, as a priority for next year.

Mr. John Bacca of 51 Cedar Ridge Boulevard addressed Council as the second spokesperson for the group, stating he has resided at this address for the past 37 years, and flooding has been an issue all along as there is no grade to take the groundwater away.

The Director of Engineering & Works stated he would like to get his engineering crews to survey and measure the grades to provide Council with recommendations to address the residents' drainage concerns for consideration likely during budget time, unless Council wishes to approach a long term solution through a Local Improvement By-law. Council Members acknowledged it has been a difficult year for flooding at many locations around the Town this past winter, and thanked Mr. Martin and the Cedar Ridge Boulevard residents for their presentation.

# 11.5 Resolutions - Building Permit Bonds - Staff Report from Director of Engineering and Works

Mr. Losier's Staff Report explained to Council as part of the Building Permit Process, applicants are required to post Construction Bond Security in order to guarantee completion of their project in accordance with the Building Code, Municipal By-laws and submitted development plans. These bonds are reviewed annually and outstanding projects are reviewed to determine the nature of the remaining item and the potential for completion. Staff make an effort to contact any applicant with outstanding bonds to provide them with an opportunity to fulfill the conditions of security and have the bond released.

If the applicant chooses not to complete their obligations or no longer exists as a company, then the bond is considered forfeited to the Town as penalty. The Town is not under an obligation to complete the outstanding work and will flag the address on the Provincial Land Gazette for prospective purchasers to address during any transactions. Any revenue forfeited to the town will be deposited to general revenue and allocated in accordance with budget requirements.
