## 8.2 (Dec.18/18) Queensbury Drive Traffic Calming - Memo from Councillor Miller & Staff Report from the Director of Engineering & Works

Councillor Miller summarized his concerns regarding Queensbury Drive Traffic Calming Project. Councillor Miller's email provided some options and suggested new types of traffic calming measures that could be used in the area.

A staff report from the Director of Engineering & Works gave background information and updated Council on the Traffic Calming Study currently underway in the Queensbury Drive area, summarized below:

implementing physical road narrowing and visual triggers, like reflective
delineators, large planters, temporary curbing that channel drivers to a
single (or 1 and a half) lane width
(rather than re-installing the speed humps. These can have similar speed
impacts but less obtrusive impact than the humps. In addition,
implementing the use of self-enforcing methods (humps, road narrow
etc.) to take out enforcement demand on police presence.)

avoid all-way stops since they only control at intersections
 (these proposed narrowings can be used at intersections, mid-block or
 any specific locations where highest speeds are measured.)

Mr. Losier feels this is a very good test location to compare the methods and use results for introduction in the revised subdivision specifications, so they are included in initial development costs.

Mr. Losier stated that engineering staff will be monitoring impacts all summer and propose a Public Meeting in mid-October and recommendations to Council in early November.

#### 11. New Business

11.1 Award of Tender No. 2020TQ03-10 - 2020 Street Capital Program

Staff Report from the Director of Engineering & Works providing results of Tender No. 2020TQ03-10 - 2020 Street Capital Program.

Members asked the Director of Engineering & Works if staff would consider adding more streets to this year's paving program to capitalize on the favorable pricing. Mr. Losier cautioned against making any decisions right now considering the current COVID-19 pandemic. In addition, CAO Deuville noted this was a possible area for saving due to the loss of revenue and increase spending due to COVID-19.

Members also asked about the quality of asphalt used to pave municipal streets. Mr. Losier stated that problems typically arise when the base and existing pavement overlay are not prepared properly.
