#### 5. Presentations

5.1 <u>CBCL Limited - Cedar Ridge Boulevard - Stormwater Analysis Presentation and</u>
Approval to Proceed to Part "B" - 15 Minute Presentation

Mr. David Morgan, P. Eng., Senior Municipal Engineer; and Kent Tayes, P. Eng., Project Engineer, CBCL - In Attendance

A Staff Report from the Director of Engineering & Works informed Council the Town has engaged the services of CBCL Ltd. to conduct an analysis of the drainage catchment area in the upper Cedar Ridge Boulevard neighborhood. Residents were concerned that many of the lower lying properties were subject to periodic flooding, especially during rain events. Mr. Losier noted design work will need to be completed by the consultants as a next step to see where the \$200,000 identified in the 2020 budget is to be spent. This will enable the Consultants and Staff to prepare various phasing options for Council's consideration.

Mr. Morgan presented CBCL's findings of their overall drainage review of the area between 60 Cedar Ridge Boulevard and 120 Cedar Ridge Boulevard, including an examination of existing conditions and potential downstream impacts. The Storm Water Analysis looked at the existing storm water drainage, the hydraulic analysis and storm water modelling of existing drainage system, did public consultation sessions, reviewed system constraints, presented upgrade options and phasing as well as recommendations for next steps.

They have identified two distinct drainage areas, both impacting the Cedar Ridge area. In both catchment areas, CBCL is recommending some form of clear water storm sewer, a separate pipe dedicated to drainage of the impacted properties and design to avoid external impact of surface runoff and flooding. Mr. Morgan stated hydraulic modelling indicates most of the existing piped storm drainage system between No. 73 and 120 on Cedar Ridge Boulevard is considered under capacity for today's magnitude of rainfall. Standard practice in 1980 to 2000 was to connect foundation drains from homes to the municipal storm piping in the street right of way.

The obvious option to upgrade the older drainage infrastructure comes with an estimated price tag of \$4-5 million in construction costs and would likely cause impacts downstream due to increased flows.

A more feasible option, Mr. Morgan recommended, is to upgrade the drainage system in phases

- Phase 1 Ditch and Culvert Upgrades between 70 and 54 Cedar Ridge Boulevard, \$150,000; (Could be done by Town crews).
- Phase 2 Install dedicated storm sewer for foundation drains from Civic #104 to Civic #80 Cedar Ridge Boulevard, (\$655,000); and
- Phase 3 Dedicated Storm Sewer for foundation drains from 70 to 54 Cedar Ridge Boulevard, (\$415,000).

Council Members directed various inquires to CBCL representatives and Town Engineering Manager, Mark Morrison re the Cedar Ridge Boulevard drainage review.

#### 8. Unfinished Business

8.1 (January 21/20) Response from Marc MacLeod, Ex. Director, Fundy Regional Service Commission Re Removal of Single Use Plastic Bags from

Recycling Stream; and, Recommendation for Greater Saint John Region Municipalities to adopt a Plastic Bag Reduction By-law

In Attendance: Brenda MacCallum, Public Relations & Program Development Officer, Fundy Regional Service Commission

Ms. MacCallum expanded upon the letter sent by Marc MacLeod dated February 13, 2020, responding to Quispamsis' previous letter asking the FRSC to extend the March 1, 2020 deadline date for removal of single use plastic bags from the recycling stream. Ms. MacCallum confirmed, as the FRSC have not been able to recycle their plastic film for a number of years, the Commission has maintained its original position to stay with the March 1, 2020 deadline date to no longer include single use plastic bags in its recycle program. To continue a program suggesting otherwise, she stated, would not be appropriate, and the Commission intends to move forward by -

- Working with the region's waste collectors and municipal staffs to 'soft-start' the March 1, 2020 date so the process of education and change can officially begin: and,
- 2. Working with the region's municipal staff to adopt a strategy on a plastic check out bag ban which includes adoption of a by-law consistent with the municipal and provincial neighbours. While recognizing that a provincial ban is ideal, like what PEI has done and NS and NFLD are doing, it is beyond their authority, whereas municipal by-laws like the greater Moncton area has adopted, are not. They plan to work concurrently towards lobbying the Province to implement a Provincial wide ban by partnering with municipalities, LSDs and other organizations such as UMNB and the Retail Council of Canada.

Ms. MacCallum noted the FRSC have been reviewing this matter for the past two years, and during this time have looked extensively for end markets to recycle these plastics, but to no avail. The common solid waste mantra is to 'reduce, reuse and recycle', and are presented in that order with recycling being the last option. She noted acceptable plastics that can be recycled are No.'s 1, 2, and 5, which is referenced on residents' recycling bins. She concluded noting the surrounding municipalities are in the process of implementing consistent by-laws that will ban single use plastic retail bags from retail stores.

Ms. MacCullum and Mr. MacLeod be thanked for their response, and Town Staff be directed to work with FRSC, and the Town's Waste Collector to 'soft-start' the March 1, 2020 date, and further, while recognizing that a provincial ban is the best solution for the implementation of a ban on single use plastic bags, but is beyond

the municipality's control, the Town of Quispamsis will continue to lobby the Province for such a ban, and, in the interim, work with the Greater Saint John Region, through the Fundy Regional Service Commission and neighbouring municipalities with the view towards adopting similar municipal by-laws as a regional approach to ban single use plastic bags in retail outlets located in the Greater Saint John Region, similar to what the greater Moncton area has done.

- 8.2 (Jan 21/20) Update on Extended Producer Responsibility Program for Packaging and Printed Paper for the Province of New Brunswick
  - 8.2.1 EPR-PPP Update from Marc MacLeod, Executive Director, Fundy Regional Service Commission

Mr. MacLeod's correspondence provided an update to Council on the status of the PPP – EPR Program. The Province, he noted, had announced last October that a PPP Program would be developed in consultation with key stakeholders and Recycle NB. The formal consultations began in December with stakeholders, and since that time, the government has continued to engage with the RSC on a regular basis to discuss the feedback from stakeholders that will form the basis of the regulatory framework governing PPP. Mr. MacLeod attached for Council's reference a letter to Minister Carr from the FRSC congratulating the Province on its recent announcement and offering suggestions for opportunity for a better approach to EPR than previous programs, considering the huge potential impact PPP will have on New Brunswickers. These include – Transfer Cost to Industry – Increase Diversion – Increase Jobs – Increase Reinvestment – Increase Assets and Increase Accountability.

8.2.2 Update from Department of Environment & Local Government - February 2020 - Development of a Regulated Framework for an Extended Producer

Responsibility Program for Packaging and Printed Paper for the Province of NB

The DELG's update provided the proposed regulatory framework for the EPR for packaging and printed paper (PPP) that is being developed in collaboration with RNB and stakeholders. The goals of the program are to make producers responsible for the management of PPP products and to increase the amount of waste diverted from landfills. Next steps will include

- Feedback on the draft regulatory framework;
- Draft Amendments to the Designated Materials;
- Regulation Clean Environment Act;
- 30-day public comment period on draft regulation;
- Finalize draft regulation based on public feedback; and
- Approval of regulation by government.

#### 10. By-laws

10.1 (May 1/2018) Proposed Smoke Free By-law No. 059 and Proposed Smoke Free Policy No. 065

A joint Staff Report from the Human Resources Manager and the Director of Community Services stated, further to Council's direction to Staff to create a smoke free by-law that would prohibit smoking and vaping on all municipal property, including roads and sidewalks; they are attaching a Proposed Smoke free By-law No. 059 for Council's consideration of first and second reading. The proposed by-law, if enacted, will become effective April 1, 2020. In addition, they have also drafted a Smoke Free Policy for Council's consideration that will apply to town employees and mirrors the Smoke Free By-law to ensure consistency. To support staff interested in quitting smoking, the report indicated, a subsidized nicotine replacement therapy program has been offered.

A Staff Report from the Director of Engineering & Works indicated in addition to the base machine, the tender includes the supply of a general purpose loader bucket, counterweights, sidewalk angled plow blade, slat/sand spreader and a 60 inch wide snow blower. A separate price, he wrote, was given for a front mounted Icebreaker in case budget permitted, however this option was quoted at \$19,500, so the Town will be considering this option potentially as part of the 2021 budget.

# 11.2 <u>Kingsview Subdivision - Phase 18 - Two (2) Lot Subdivision - Staff Report from Municipal Planning Officer</u>

A Staff Report from the Municipal Planning Officer informed Council the proposed Kings View Subdivision Plan – Phase 18 shows a two (2) lot phase of the Kings View Subdivision proposing to create Single Family Residential building lots fronting an extension of Kings Way Drive and two Local Government Service Easements. This phase, he noted, was assented to by Council in March of 2016, however, the previous Developer did not continue with the development. It requires Council assent as it proposes the laying out of a public street unless the plan is assented to by Council pursuant to Section 88(1) of the *Community Planning Act*.
