5.1 <u>CBCL Water Supply and Distribution Study Presentation (Project No. 172895.00)</u>

Presenter: Brian Moreau, CBCL Limited

Mr. Brian Moreau of CBCL Limited made presentation to Council providing an overview of the Water Supply and Distribution Study. Highlights of the study:

- Study objectives include:
 - o Provide a long-term understanding of the water system
 - Support planning and decision making for new development within the town limits
 - Support development of Comprehensive
 - Asset Management Plan
 - Align with Municipal Plan Recommendations
- Further, Mr. Moreau reviewed and discussed the study components and considerations, noting the following:
 - Review of existing Water Distribution System (Downeast and Ridgewood Park) ~ providing details on demands, piping, connections, aquifer and reservoir.
 - Hydrogeological Assessment ~ understanding the Town's existing groundwater systems and those of the region, determining the potential to expand municipal services using existing wells, reviewing the capability of aquifers with the Town to meet current and future demands
 - System Constraints
 - Full Expansion of the Water System ~ with costs

 Near-Term Expansion of the Water System (Downeast and Ridgewood Park)

Council Members asked for clarification on a couple of the study components and thanked Mr. Moreau for his presentation.

Mayor Clark noted the importance of open ditching.

6. Public Hearings

6.1 Zoning By-law Amendment – Schedule of Fees – Proposed Changes to Fees and Land for Public Purposes Use in all Zones – Public Hearing

Presentation by Municipal Planning Officer, Dwight Colbourne

Mr. Colbourne presented an overview of the proposed changes to the Zoning By-law fee schedule Schedule of Fees. He noted, the review was completed by the Planning Department and in accordance with the direction of Council as proposed in Section 9.9.1 of the Municipal Plan By-law 054.

He summarized the proposed changes, listed below:

- The goals of the schedule of fees review:
 - determine if the fees being charged presently are reflective of the level of effort and resources required to provide the service,
 - adjust fees appropriately to reflect the level of effort where there is a significant discrepancy,

- compare the Town's fee structure with other municipalities in the region and provincially to bring them into relative alignment, and
- introduce new fees for services being provided for which no cost recovery mechanism is currently in place.
- Mr. Colbourne, further noted, that one of the seven Building
 Principles outlined in Section 2.3 of the Municipal Plan is decisions
 related to development are to be predictable, fair and cost-effective.
 Recognizing the importance of this principle, the Planning
 Department is submitting to Council proposed changes to the Fee
 Schedule for administration and development services regulated by
 the Zoning By-law.
- Additional, he highlighted the proposed change that the Planning Department is requesting to add to the Zoning By-law regarding Land for Public Purposes Use in All Zones include –
 - The Planning Department is requesting an addition to the Zoning By-law that would address this item. The wording of the proposed Amendment No. 038-29 to Zoning By-law 038; is as follows:
 - (2) Land designated as Lands for Public Purposes may be used for the recreational or other us or enjoyment of the public notwithstanding the zone the land is located in.

Mayor Clark asked three times if anyone wished to speak further for or against the proposed Zoning By-Law No. 038-29. No one further spoke.

Council Members thanked the Municipal Planning Officer for his presentation.
