5. Presentations

5.1 Public Presentation - Dr. Caley McNamara Crowdis - 224 Hampton Road - PID

No.251835 - Residential (R1) to Central Commercial (CC) for Proposed

Professional Office Building (Two Storey)

Councillor Luck left the meeting.

Dr. Caley McNamara Crowdis, Licensed Provisional Psychologist, made presentation to Council formally applying to have the property located at 224 Hampton Road rezoned from Residential (R1) to Central Commercial (CC). Dr. McNamara Crowdis stated the KV Psychology & Wellness Clinic, currently located in Rothesay, wishes to expand its practice, and plans to build a 6000 sq ft two storey professional office building, with the second floor occupying the Psychology Clinic, with plans to rent out the first floor as professional office space. The upper parking lot would contain 22 parking spaces and the lower parking lot 18, as per the site plan prepared by Blair Construction Inc. and Lockharts Residential & Commercial Designs.

A Staff Report from the Municipal Planning Officer informed Council the property is situated directly off the Hampton Road, a main collector, and is situated close to core commercial service amenities. It will be serviced by municipal sanitary sewerage and a drilled well. The property consists of 5273 sq. metres, (1.3)

acres), and provides sufficient space to accommodate the proposed development and required parking. Access will be provided from both the Hampton Road and Ranch Avenue. In closing, Mr. Colborne informed the proposed development is in keeping with the intent of the new Municipal Plan Bylaw No. 054 providing a facility that services a healthy lifestyle, aligns with the Land Use Designation Policy for Central Commercial along the Hampton Road, and strengthens the sense of community around the Town Hall and Arts and Culture Park.

8. Unfinished Business

8.1 (Apr. 17/18) Performance Audit - Draft RFP Prepared by CAO Susan Deuville

Council Members reviewed the draft Request for Proposals prepared by CAO Susan Deuville for Consulting Services for an Internal Performance Audit and Review for the Town of Quispamsis.

Deputy Mayor O'Hara requested the following revisions be made to the RFP:

1) Part 2 - Project Description - All Departments and Operations of the Municipality *will* (rather than *may*), be subject to this review;

- 2) Part 8 Proposal Evaluation Reduce the evaluation matrix criteria from five items to three; and change the proposed weight points, for each of these three, as indicated 1. Quality and Completeness 35 points, (rather than 5 points); Consultant's Experience/Reference 35 points, (rather than 25 points); and, Cost 30 points, (rather than 50 points).
- 3) A Selection Committee be appointed to evaluate the proposals and, once awarded, to receive regular updates on the ongoing status of the review. Deputy Mayor O'Hara proposed the Committee consist of Mayor Clark, Deputy Mayor O'Hara, Councillor Luck; and the CAO, along with one other Town Director.

CAO Deuville stated the draft RFP presented to Council provided her name as the Town representative facilitating the RFP on Council's behalf, stating the Audit, if set up with the proper parameters should not require a subcommittee driving or altering the review. Rather, she suggested, the successful proponent should report directly to Council, as it is all of Council who will be authorizing the review and should be the group involved in its ongoing status.

8.2 (May 15/18) Capital Streets Program 2018 - Recommendations Re Addition of Streets due to Low Asphalt Prices - Staff Report from Director of Engineering & Works

The Director of Engineering and Works expanded upon his Staff Report, noting Council had requested further information on the scope of the 2018 Street Capital Tender in consideration of the favourable asphalt tender prices received in the 2018 tender, at \$85 per ton vs. last year's, \$103 per ton. He presented 4 scenarios to increase the scope of the 2018 Street Capital for Council's consideration. Mr. Losier noted the current budget has \$16,000 remaining and suggested this amount be unassigned to provide minimal contingency. The

Contractor has confirmed, if a decision is made in the near future, he will honour the tender prices for added work.

To take advantage of the low asphalt costs, Council authorize proceeding with Scenario 1, completion of the Colton Brook 3000mm cross culvert so that the road construction along the Colton Brook can be completed this calendar year, estimated cost of \$271,000; and also to proceed with Scenario 2, completion of the Quispamsis Road from the 2017 limits to the crest of the hill at Cambridge Avenue - includes 534m of of road base pulverizing and resurfacing , for an estimated cost of \$315,000; and the total cost of \$586,000 to complete these added works be funded through borrowing over a 15 year period.

9. Correspondence

9.1 <u>Climate Change Committee - UMNB CCEI - Draft Letter to UMNB - Proposed Resolution to Lobby Province to Implement Practices to Help Local</u>
Government in its Climate Change Initiatives

A Staff Report from the Town Clerk provided an update on the Town's UMNB Climate Change and Energy Initiative, which includes finalizing the Town's GHG inventories, both corporate and community, and development of a Community Energy Plan. A draft letter to UMNB was attached that resulted as a takeaway from a recent CCEI Workshop, that provided considerations for the Province to help improve opportunities for local developers/contractors in their sustainable development efforts.

Council authorize sending the draft letter, removing the reference of 'renewable tariff policy', under Mayor Clark's signature, to UMNB, requesting, at their upcoming Annual Conference, UMNB send a resolution to the Province requesting their approval processes be streamlined to encourage and promote sustainable energy initiatives .to help NB communities in their efforts become more successful in their transition to renewal energy sources.

9.2 Geraldine Black - Request to Present Traffic Stats on Hampton Road

Mrs. Black expanded upon her correspondence referencing traffic stats she received from Sgt. Evan Scott, Traffic Division of the Kennebecasis Regional Police Force. Sgt. Scott had indicated since January 1, 2016, there has been 19 collisions along the Hampton Road, between McCarron Drive and KVHS. Mrs. Black stated at certain times of the day, it is a high trafficked area, with daycares and schools and streets feeding onto the Hampton Road. She suggested the speed zone be reduced to 30 km per hour, noting there have been pedestrian/vehicle collisions in the area.

The Director of Engineering & Works indicated the Engineering Department is currently reviewing the configuration and upgrade options for the crosswalk system in the Hampton Road area as directed by Council. He noted the Hampton Road is a Provincially Designated Highway and any speed reductions will require the approval of the Province, while any additional costs for crosswalk upgrades, signage, etc., will be borne by the municipality. Mr. Losier noted the overhead crosswalk lights recently installed near the KV Public Library cost \$40,000; while the overhead strung lights at the Lake Road crossing cost approximately \$15,000. He hopes to have information on this matter to Council by the next meeting so that any changes may be implemented in time for the fall school opening.

9.4 <u>Aphrodite's Hair Studio Inc. - Request to Amend Noise By-law to Permit Outdoor</u> <u>Music at Commercial Establishments</u>

Monique Robichaud OBrien; Owner, In Attendance

Ms. Robichaud O'Brien addressed Council as owner of Aphrodite's Hair Studio. She stated the success that keeps her business going is a strategy that she has put in place and practice every day. It includes talented stylists, aestheticians and front-end staff, treating her clients as guests as they come into the studio. This, she said, requires hard work, keeping up with the times, and the ability to change and adapt to the ever growing consumer.

Ms. Robichaud O'Brien related there has been complaints from adjacent residential neighbours concerning her outdoor music, which she has since turned down. She requested Council consider amending the Town's Noise By-law to permit commercial businesses to use outdoor music. There is research, she said, that supports the use of music and commerce as it affects people in a positive way.

The Director of Engineering and Works informed Council under the current provisions of the Town's Noise By-law, evidence that one person is unreasonably disturbed or annoyed by a noise is evidence that a noise is disturbing the inhabitants. Restrictions from this would include fireworks when authorized by the Town; athletic and recreational activities on recognized sportfields, traditionally scheduled festive and religious activities, parades, and other community celebrations when authorized or sponsored by the Town. As Ms. Robichaud-O'Brien has turned down the music, he said, she is currently working within the confines of the by-law.

Council permit Ms. Wendy Pottle, the complainant, an opportunity to address Council.

Ms. Pottle informed Council she was the resident who complained about the music from Aphrodite's Hair Studio, speaking on behalf of her elderly parents who reside next door to the Hair Salon. She said the music when it is projected out, has a tinny, and continuous sound 6 days a week, which has caused an annoyance to her parents. Over the years when it became too much, she would call the Hair Salon and Ms. Robichaud-O'Brien would accommodate her concerns by turning the music down. However, this was not the case when she recently requested the music be turned down which is why she registered a formal complaint with the Town.

Correspondence from Ms. Wark requested space be made available in one of the Town facilities to permit Deby Siemens to expand her exercise programs to seniors. She is offering programs now at the qplex pool during summer months as well as at some of the seniors' homes.

Ms. Purton Dickson informed Council, she has spoken with Rothesay resident, Ms. Wark who is looking to have the seniors' fitness programs expanded, and would like approximately one hour of space provided per week. She has written the same request to the Town of Rothesay.

Ms. Sherwood's letter expressed concerns about the safety of a section of the Gondola Point Road that abuts her property, noting the pavement is cracked and it appears that a large vehicle could easily end up in the river should the bank decide to give away. She noted a small portion of the road received a band-aid repair during the recent flooding, and feels it would now be appropriate to reexamine the safety of that portion of the Gondola Point Road.
