5. Presentations

5.1 Conservation Council - Lois Corbett, Executive Director, In Attendance

Ms. Lois Corbett presented the Conservation Council's Renewable Solutions NB Tour that is aimed towards bringing together renewable energy producers, local business organizations, local elected officials and others interested in supporting renewable energy in communities across New Brunswick.

The challenge, Ms. Corbett advised, is to limit the ratio of carbon dioxide in the Earth's atmosphere to 350 parts per million,(currently at about 400 ppm), to keep global warming to below 2 degrees Celsius by 2050. This, she said, can happen by moving quickly with ambition beyond the days of burning coal, oil and natural gas and instead using 100 per cent renewable energy sources by 2050 at the latest. In New Brunswick, this means –

- Cleaning up the electricity system;
- Investing heavily in renewable energy technologies; and
- Investing heavily in energy efficiency and building retrofits.

Towns and Villages, Ms. Corbett stated, are well placed to act on building new energy systems, as they know their communities, are accustomed to setting targets and planning into the future, and also directly influence municipal plans for transportation and building codes. She cited renewable energy examples of what other municipalities are doing globally to make a positive difference in renewable energy. Home grown models include the construction of a passive solar house in Jemseg, NB, which

reduced the electricity bill in winter months from \$500 to \$150 per month, an initiative in Ontario that has implemented micro solar power stations in over 10,000 of their homes, schools and churches. The electrification of transportation is the next major opportunity for significantly reducing GHG emissions, representing 25 percent of Canada's carbon footprint. The City of Burlington in Vermont has gone 100% renewable. She commended Quispamsis for its many efforts in building a sustainable community, noting it was the first NB Municipality to join FCM's Partners for Climate Protection, and leading in design with the first LEED Arena in Atlantic Canada.

Council Members commended Ms. Corbett for the very informative presentation, and asked that she keep the Town updated on various sustainable projects and developments that are taking place in other communities globally.

5.2 <u>Union of Municipalities of NB's, (UMNB), Climate Change & Energy Initiative (CCEI) - Eddie Oldfield, Owner/Principal of Spatial Quest Solutions, Advisory to UMNB CCEI Initiative, In Attendance</u>

Mr. Oldfield acknowledged the "Paris Climate 2015" Conference has brought Climate Change to the forefront with all parties of the UN Framework Convention on Climate Change facilitating countries to sign an agreement to limit greenhouse gas emissions and global warming. New Brunswick, he said, has already announced its target to reduce GHG emissions to 10% below the level of 1990 by 2020, and to reduce the GHG emissions between 75% and 85% below the level of 2001 by 2050. He stated his company has been engaged by UMNB to help move NB municipalities forward as Smart Energy Communities.

Mr. Oldfield noted Quispamsis was the first municipality in New Brunswick to join FCM's Partners for Climate Protection Program, and invited the Town to become one of 12 New Brunswick Municipalities to participate in this 18 month project. The contribution by the Town would be between \$9000 to \$12,000 maximum, split over two years, for the production of a high quality GHG inventory, updated Local Action Plan, Community Energy Plan/Mapping and Community Energy Planning project identification. Additionally, the Local Action Plan would identify opportunities and projects eligible for further GMF Funding with targets for GHG emissions reduction. Mr. Oldfield stated, as a participant, Quispamsis' green initiatives and achievements will be recognized by FCM and promoted nationally.

In closing, Mr. Oldfield stated he would like to receive responses from municipalities by April 2016. Once the required number of municipalities confirm their participation, UMNB will submit the funding application to FCM GMF for 50% of the project's overall costs. UMNB will also be applying to NB Environmental Trust Fund for 35% of the projects cost, and municipalities that participate will contribute 10% of the project cost, shared amongst the participants.

9.1 <u>Letter from The Honourable Brian Kenney, Minister of Environment &</u>
Local Government - Updates on Local Government Issues

Correspondence from the Honourable Kenney highlighted key points from budget estimates that affect local government, for instance the Community Funding and Equalization grant funding was increased by \$285,000 and municipal transfers will be maintained at their current levels. The Province also remains committed to the modernization of local government including the modernization of legislation, particularly the *Municipalities Act* and the *Community Planning Act* to give municipalities powers to promote development and become hubs of job creation. He also noted the Province will continue to work with communities that express interest in studying voluntary restructuring options to strengthen their capacity and sustainability in the long run.

9.2 <u>80 Millennium Drive – Big Rock Plaza – B & R Brown Holdings Ltd. – Business Development under the Development Scheme By-law for Millennium Drive – Staff Report from Municipal Planning Officer</u>

Mr. Colbourne's Staff Report informed Council B & R Brown Holdings Ltd. plan to develop on their property located at 80 Millennium Drive, (7.65 acres), adjacent to the Home Hardware Store, a series of up to five upscaled multi-functional buildings designed to house retail, office, service,

food service and light manufacturing businesses in spaces between 457 sq.m m and 1372 sq.m ft. The intention is to construct building number one on the north east corner of the lot, (adjacent to Home Hardware), with construction commencing in the spring of 2016. Future buildings will be constructed one at a time as demand dictates. Financial implications include the extension of the water system to connect with Granite Drive if desired by the Town, but this is not a requirement to approve the proposed development. The process of approval, Mr. Colbourne stated, is guided by the Millennium Drive Development Scheme By-law No. 017. Council, the Building Inspector, and any other persons deemed necessary by the Development Officer have up to 14 days to submit recommendations, in writing, to the PAC. As part of the process, PAC have sent notices, he said, to the property owners with 100 meters of the subject property.

The Director of Engineering and Works noted if Council Members, following their review of the package, have any input or feedback concerning the proposed development to provide their comments to the Development Officer within 14 days of the date of the Staff Report, (March 23, 2016).

NOTICE OF WARRANT OF ASSESSMENT TO THE TOWN CLERK
