#### 2. Mayor's Comments

Mayor Clark announced Council meetings are expected to return to in-person in April with a newly upgraded audio and video system that is presently being installed. The new

system will allow automated streaming of meetings, a popular feature amongst residents that will continue long after the pandemic.

Mayor Clark stated the Homestar Dog Park will be closed March 17 and 18 to allow for the installation of the new lighting, which should be operational within the next few weeks, and will allow use of the dog park later in the evenings.

The qplex, Mayor Clark noted, is in its 10<sup>th</sup> year of operation, and this milestone will be commemorated over the coming weeks. He encouraged everyone to share their favourite memories of the qplex on social media.

#### 5. Presentations

# 5.1 <u>ACAP Saint John - Presentation of Town of Quispamsis' Climate Change</u> <u>Adaptation Plan</u>

Presenters: Bailey Brogan & Jamy-lynn McDonald, Climate Change Coordinators, ACAP Saint John

Ms. Bailey informed Council ACAP Saint John have been working on the Town of Quispamsis' Climate Change Adaptation Plan over the past year through funding from a Provincial Environment Trust Fund grant. In preparing the Plan, a review was conducted of the Town's Planning Documents, Development Scheme, EMO Plan, Asset Management Strategy, Corporate & Community GHG Action Plans, Flood Damage Reports, Water Supply and Distribution as well as the Town's Zoning, Subdivision, Sewer and Water By-laws. In addition, ACAP Saint John worked with a Steering Committee made up of town representatives on vulnerability and risk assessment, and solicited public input through on-line surveys and public events.

The Risk Analyses indicates the Town does not have any Extreme or High Risk Rating items, and recommends the Town should prioritize the Medium-High Climatic Change ratings. For Quispamsis this included Riverine Flooding and Increased Storm Events as a result of changes in precipitation and changes in temperature. ACAP SJ developed a list of 48 action items the Town can implement to increase its resiliency to climate change impacts – some of which include-

- Alert the pubic to extreme temperatures;
- Integrate green infrastructure;

- Protect natural buffers;
- Engage public in emergency preparedness;
- Education on reducing water usage;
- Upgrades along Gondola Point Road;
- Increase availability of flood mapping;
- Update zoning in flood prone areas;
- Watershed and stormwater planning.

## Adaptation Strategies include –

- 1. Modifying policies, plans and procedures;
- 2. Building or infrastructure upgrades;
- 3. Improving community awareness and public education;
- 4. Building resilience to climate impacts.

#### Next steps include -

- Adoption of the Plan by Quispamsis Town Council;
- Refer the Plan to the Climate Change Committee to address implementation; and
- Include adaptation in municipal updates and development planning.

# 5.2 PRO Kids Update - Summary of 2020 PRO Kids Events, Fundraisers and Staffing Structure

Presenters: Holly Knight, Quispamsis Representative & Amy McLennan, PRO Kids Manager, City of Saint John

Ms. Knight and Ms. McLennan provided to Council an update on PRO Kids recent activities. Ms. Knight noted the municipalities of the greater Saint John area, including Quispamsis, financially support the administrative costs of the program,

while funds raised through sponsorships and fundraising events support the placements of approximately 1000 children each year in various recreational and cultural activities. In 2020 the program saw more first time applicants whose families' financial situations had been negatively impacted by job losses due to the pandemic.

Mayor Clark turned the Chair over to the Deputy Mayor and received clarification from Ms. McLennan confirming that the City of Saint John's funding contribution has not changed from previous years. She noted the program's main challenge associated with COVID is many activities have not been happening due to mandatory orders, but once the pandemic is over, a truer impact of poverty related to COVID will become more evident.

NOTICE OF WARRANT OF ASSESSMENT

WHEREAS pursuant to By-law No. 011-20, passed on the 18<sup>th</sup> day of August, 2020, the Council of the town of Quispamsis has completed as a local improvement the Installation of Storm Sewer Works, at a cost of \$32,011.79 within the twelve months preceding the 31st day of March, 2021.

9.1 <u>Canadian Transplant Association - New Brunswick - Request for "Green Shirt Day"</u>

<u>April 7, 2021 and Request to "Light the Town Green" the Week of April 18 in</u>

Recognition of National Organ & Tissue Donation Awareness Week

In Attendance: Ms. Nichole Elizabeth, Provincial Director

Ms. Elizabeth expanded upon her requests for the April 7 *Green Shirt Day*; and the April 18 – 24, 2021 *Light Up the Town Green Week*, both in recognition of Organ & Tissue Donations. In New Brunswick, people can register to be an organ and tissue donor through NB Medicare, noting it is also important to share these wishes with loved ones. The Canadian Transplant Association has long partnered with organizations like Canadian Blood Services and the Kidney Foundation in these efforts. In addition, following the tragic Humboldt Broncos bus crash in 2018, the CTA has also teamed up with the Boulet family in their efforts to raise awareness of organ donation. The family honoured their late son, Logan's wishes to be an organ donor, and because of this, six lives lived on. Ms. Elizabeth noted there is no age restriction for organ donations, noting the donated organs receive rigorous testing to ensure they are in a healthy state before being transplanted.

## 10. By-laws

#### 10.1 Proposed Remuneration By-law Amendment No. 018-09

In Attendance: Ms. Joanie McGraw, HR Manager, Town of Quispamsis

Ms. McGraw noted the Town had done a full review and implementation of a new pay structure for all non bargaining employees in 2016, utilizing the median to determine salaries. This included a balance between internal equity, external competitiveness, and fiscal responsibility. In 2019, a full Compensation Review for Council Remuneration was conducted by an independent consultant, Karen Gordon and Associates. She reviewed Council's remuneration in comparison with 12 other Maritime municipalities that were in the \$33m annual revenue category.

The results of Ms. Gordon's review indicated Quispamsis Council compensation is under market and close to the 25<sup>th</sup> percentile. Further, survey results indicated that Council's current Professional Development Budget is over market and close to the 75<sup>th</sup> percentile. With this in mind, the Consultant recommended the following recommendations, to become effective with the newly elected Council, in June of 2021:

The overall change to the combined budget of Salary and Professional Development is an annual increase of \$12,062 to the total Council Compensation Budget.

Council members expressed their views concerning the proposed change to the Council Remuneration By-law. The majority of members spoke in support of the recommendation, acknowledging there has not been an increase in five years, Quispamsis is the 6<sup>th</sup> largest municipality in the Province, the proposed amendment is transparent for those looking to run in the upcoming election, and it represents fair market value, utilizing the 50<sup>th</sup> percentile market median for the new Council. Councillor Rioux, and Mayor Clark, (handed Chair over to Deputy Mayor), spoke against the proposed amendment, stating during a Pandemic, when many people have experienced financial hardship, is not the time to be considering an increase to Council's compensation. Mayor Clark resumed the Chair.

#### 11.1 New Regional Economic Development Agency for Greater Saint John

11.1.1 New Name - "Envision Saint John - The Regional Growth Agency"

Correspondence from the REDAGSJ noted the new name represents –

- The word "Envision" is a call to action to envision a more prosperous and inclusive future for the Greater Saint John Region.
- It invites residents to envision a brighter tomorrow in a community that is attracting investment, tourists and residents.
- When speaking to external markets, it is a direct encouragement to consider the Greater Saint John region as a place to invest, visit and live.
- It speaks to the Growth Mindset the agency will bring to the region.
- It is short, declarative and aspirational, speaking to the potential of the region.
- The tagline The Regional Growth Agency provides context and underscores the regional nature of the agency's mandate.

# 11.2 <u>Nominating Committee's Recommendations - Climate Change Committee</u> Appointments

A recommendation from the Nominating Committee acknowledged there are currently three projects underway as part of the Town's Climate Change initiatives –

- QUEST Smart Communities Benchmarking Report; (Scores the Town's Community Energy Plan, what has been completed, and what remains to be done);
- 2. ACAP Saint John's Preparation of Quispamsis' Adaptation Plan; (to address risk management in response to climate change impacts); and ,
- 3. QUEST Sustainable Energy Community Acceleration Program, (will offer a range of services customized to the Town's needs including an economic impact assessment of the Community Energy plan)

The Town has been fortunate to participate in these projects at little cost to the municipality due to QUEST and ACAP being able to access government funding on the Town's behalf. While projects like these compile and analyze a large amount of useful data and will be used to move the Town's Community Energy Plan forward; it is important to have staff with expertise and technical skillsets on the Climate Change Committee to assist in the implementation of these recommended actions.

## 11.3 <u>Cedar Ridge Boulevard - Stormwater Analysis Approval to Proceed to Part "C" -</u> Tender Period

Staff Report from Director of Engineering & Works – Mr. Losier's report noted the Town proposed a three-part format for the RFP, Part A was Preliminary Design Costing and Phasing; Part B was Detailed Design; and Part C is Tender Period Services and Contract Administration. The Town is now prepared to proceed to the tender period for summer construction. The 2020 Budget identified \$200,000 to address the initial design and there is an additional \$200,000 from the 2021 budget that will be added to the previous year's budget.

#### 11.4 Award of RFP No. 2021TQ02-8 - gplex Pool Heat Exchanger

Staff Report from Director of Community Services – Ms. Purton Dickson's report noted the pool temperature has been an issue for the past 10 years. The Town has added to the current heat exchanger and purchased a cover for the deep end of the pool, yet the temperatures remain lower than desired. The proposed unit is nearly six (6) times larger than the current unit and has been specified to achieve a temperature range of 78.82 degrees Fahrenheit or 25-27 Celsius.
