1. Approval of Agenda

2. Mayor's Comments

<u>Purple Day</u> - Mayor Clark acknowledged members around the Council table were all wearing purple ribbons in recognition of March 26, 2019 being designated as Purple Day in New Brunswick in an effort to raise epilepsy awareness and help improve the quality of life for people with epilepsy. He stated epilepsy is one of the most common neurological conditions, estimated to affect more than 50 million people worldwide, and more than 300,000 people in Canada.

<u>Meenan's Cove Park Survey</u> - Mayor Clark encouraged residents to complete the short survey on the Town's website requesting public comments and suggestions on the amenities at Meenan's Cove Park, including the beach house, the boat launch, parking as well as potential flood mitigation strategies with the overall view to improve the park's efficiencies.

<u>Canada Winter Games</u> – Mayor Clark extended congratulations to Quispamsis athlete, Isaiah Haya, who won a gold medal in boxing at the recent Canada Winter games. He noted the Canada Games athletes will be recognized at the April 2, 2019 meeting.

5. Presentations

5.1 Gondola Point Wastewater Pumping Stations and System Optimization Study

Presenter: Mike Rogers, P. Eng., and Jeremy Clack, P. Eng., Crandall Engineering

Mr. Rogers and Mr. Clack presented an overview of the Gondola Point Road Wastewater Pumping Station Overflow and Optimization Study. The review encompassed the five (5) wastewater pumping stations built in the 1970's on or near the Gondola Point Road,

- Lift Station 1 21 Robert's Lane,
- Lift Station 2 2 Buckley Lane,
- Lift Station 3 507 Gondola Point Road,
- Lift Station 4 565 Gondola Point Road.
- Lift Station 5 623 Gondola Point Road, and
- The two wastewater pumping stations built in 2005 at Matthew's Cove and Vincent Road.

Study Components Included -

- inflow and infiltration,
- · conceptual lift design,
- station elimination review,
- optimization of pumping configuration,
- energy analysis,

- review overflow configuration,
- options cost estimates recommended prioritization.

Options Presented -

 Option 1 – base scenario – to replace the existing stations in the current configuration, sized based on peak flows +15%;

Total Cost \$5,630,000 (No paybacks from future energy savings)

 Option 2 – Lift Station 1 to pump over the hill to existing sewer on Pacha Dale removing these flows from all downstream lift stations.

Energy Usage including the additional pumping required for the same volume from Lift Station 5 through Matthew's Cove and Vincent Road Stations.

Total Costs \$4,600,000 (Includes annual energy savings of \$15,622.61 over Option 1)

 Option 3 – Builds on Option 2 and adds flows from Lift Station 3 which get pumped to Life Station 1, therefore flows from Lift Station 1, 2, and 3 are all removed from the remaining downstream stations.

Total Costs \$5,270,000 (Includes annual energy savings of \$20,352.31 over Option 1 and \$4,729 over Option 2)

Recommendations:

Short Term -

- Undertake electrical upgrades at Matthew's Cove & Vincent Road Lift Stations;
- Design and construct new overflow control structures at Lift Stations 1, 2, 4, and
 5;
- Video inspection of pipes in Sherwood Park and smoke testing;
- Begin entering into discussions with the True Life Church to obtain the land to install new force main piping through to Pacha Dale.

Long Term -

- Undertake system upgrades as described in Option 2 for most cost effective solution OR
- Undertake system upgrades as described in Option 3 for most energy efficient solution

• Ensure future lift stations are installed with standby generators.

Crandall Engineering be thanked for their submission and presentation of the Technical Report on the Gondola Point Road Wastewater Pumping Station Overflow and Optimization Study, and the Report be referred to the Director of Engineer for further review and recommendations back to Council on the best approach to proceed with the Gondola Point Road Wastewater Pumping Station Overflow and Optimization project.

5.2 Q-1-1 Council Presentation

Presenter: Susan Deuville, CAO and Chrissy Scott, PTech, GIS/Planning Technologist

Ms. Deuville and Ms. Scott presented and demonstrated the new Q-1-1 Issue/Complaint Management System that will provide an enhanced service delivery of automating citizens' issues and service requests. The software works with the Town's existing Esri and City Works systems, is user friendly, available online 24/7, and will improve documentation of any point of action or communication re citizen concerns. Ms. Deuville pointed out the Q-1-1 is to be used for non-emergency issues, and any emergencies should still be reported by phoning the Town's main line. Issues submitted to the new system will be responded to by the appropriate Town Department in order of priority. It will also be a great tool to capture important information concerning service calls It was noted the Q-1-1 will be launched publicly on the Town's website March 20, 2019.

CAO Deuville concluded by thanking Staff Members, particularly Chrissy Scott and Sherri Levesque who have been instrumental in the implementation of the Town's new Issue/Complaint Management system.

8.1 (Dec.5/17) Master Enterprises Ltd. - Hamel Drive Integrated Development - PID

No. 173732 - Request to Approve Amending Development Agreement

Municipal Planning Officer, Dwight Colbourne, was in attendance and expanded upon his Staff Report. He informed further to the Public Hearing held last January, the transfer of ownership of Master Enterprises Ltd. from Murray Carpenter to the new owner, Andrew Harrigan, has been completed.

The proposed revisions to the agreement include -

- the development phasing schedule,
- the street construction schedule for Hamel Drive;
- option to include single-family dwelling units while keeping the maximum number of units for the whole development at 109;
- revision to payment schedule for the outstanding \$78,000 levy for the sanitary sewer system work completed by the Town on behalf of the previous owner, and spread over four phases vs. three, with full payment received no later than October 2024.

NOTICE OF WARRANT OF ASSESSMENT

WHEREAS pursuant to By-law No. 011-2018-1, passed on the 17th day of July, 2018, the Council of the town of Quispamsis has completed as a local improvement the Installation of Storm Sewer Works, at a cost of \$10,926.52, within the twelve months preceding the 31st day of March, 2019.

AND WHEREAS pursuant to By-law No. 011-2018-1 of the town of Quispamsis, the owner's portion of the costs of the work to be raised by special frontage assessment is \$8,194.89;

AND WHEREAS such frontage assessment is payable in either one lump sum or ten (10) annual installments;

The Town Treasurer is THEREFORE requested to assess and levy the sum of \$8,194.89 on the several parcels of land abutting on the said work and cause the same to be collected and paid by either one lump sum or ten (10) annual installments by the owner of such parcels in accordance with the provisions of the By-laws of the town of Quispamsis.

9.1 Deer Management Plan - Correspondence from Joe Kennedy, Wildlife Biologist

Mr. Joe Kennedy of the Provincial Department of Energy and Resource Development, and the Regional Deer Committee, be informed the Town of Quispamsis accepts his recommendation and would be willing to retain a listing of interested hunters that could be provided to landowners who are looking for hunters to utilize their permits, with a disclaimer noted on said list indicating the Town does not vouch for the skills or experience of the hunters, acknowledging that it is the responsibility of the landowners to only select hunters whom they trust to hunt safely on their lands.

9.2 <u>Flood Mitigation - Spring Freshet - Deputy Mayor O'Hara's Request for Update – Staff Report from CAO Deuville</u>

CAO Deuville expanded upon her Staff Report noting the Quispamsis Emergency Preparedness Team, (QEPT), will be meeting on March 25, 2019 to discuss its preparation for the Spring Freshet 2019. She stated Staff have reached out to NBEMO who indicated at this time it is not their intent to offer out sand or sandbags as they did during the 2018 spring freshet flood. Ms. Deuville stated homeowners living along the river should be preparing for the spring freshet by protecting their private properties and removing debris that can float away, ensuing hazardous materials are not stored in locations where the water may access their properties. The Town will be reviewing the post action report from the 2018 flood in conjunction with its EMO Flood Response plan to mitigate flooding issues to Town infrastructure.

Council Members acknowledged it is not the Town's responsibility to provide sandbags to private property owners, and encouraged potentially impacted property owners to take preparedness actions to protect their properties in the event of spring freshet flooding. During the 2018 flood, the Province did provide sand and sandbags which the Municipality helped distribute, but this is not their normal practice.

A written request be issued to the Province of New Brunswick asking what their formal policy is with respect to providing sandbags to impacted private property owners during the spring freshet flood season.

11.3 Maple Ridge Subdivision - Phase 1B

Council grant assent to Maple Ridge Estates Subdivision Phase 1B subject to the following terms and conditions:

- Corduroy Road must be constructed in accordance with the Town of Quispamsis Subdivision Specifications and Guidelines, and the engineered design as approved by the Town;
- 2. Submission of an onsite septic report from a qualified professional completed in accordance with the Public Health Act of New Brunswick demonstrating the property can support the proposed level of development.
- The Developer must comply with the comprehensive Storm Water Management Plan as submitted to and approved by the Town for the Phase 1 and Phase 1B of the Maple Ridge Estates development;

- 4. LPP obligations to be met through the Land dedication, and reference to this area as shown on the attached plan, to be incorporated into the Development Agreement;
- 5. Filing Fees totalling Two Hundred Thirty Dollars (\$230) be submitted for a subdivision plan creating three (3) lots;
- 6. The Developer must enter into a standard Development Agreement with the Town;
- 7. The Final Plan is to be signed by the Property Owner(s) and any applicable Public Utilities; and
- 8. The Subdivision Development must be completed in accordance with all Town By-laws, Regulations and/or Policies thereto.
