#### 5. Presentations

a. Presentation to Town of Quispamsis from 2018 Canada 55+ Games Hosting
 Committee Co-Chair, Councillor Emil Olsen to Mayor Clark – Community Services
 Department – Active Senior Living Programs

Councillor Olsen as Co-Chair of the 55+ Games presented a legacy fund in the amount of \$6,500 to Mayor Clark to support the Community Services Department's Active Seniors Living Programs. With the support of corporate sponsors, municipal, provincial and federal governments, he noted the 55+ Games provided an economic infusion of over \$3.5 million into the greater Saint John area. In addition, it provided \$127,000 in legacy funds to reinvest in active senior living, and exposed over 2300 new people to the Greater Saint John area from across the country, booking 4347 hotel rooms between Sussex and St. George, 22 activities at 26 venues, and demonstrated the great infrastructure of the two hosting communities, Quispamsis and Saint John.

#### 9. Correspondence

9.1 <u>Proposed Resolution Requesting the Province to Amend the Industrial Relations</u>
Act Re Binding Arbitration

CAO Deuville's Staff Report acknowledged Quispamsis' previous request to the Province to amend current binding Arbitration with the view towards a focus on NB Municipalities' capacity to pay salary increases. Since then, the Cities of NB Association have submitted a resolution to the Province requesting that the legislation be amended to strengthen the interest of the arbitration process for achieving joint collective bargaining agreements specifically related to wages and benefits for firefighters and police in the Province, while reflecting the economic circumstances of the Province and the communities they serve.

9.2 <u>Hospitality Saint John Economic Driver of the Year Award - The 2018 World Under 17 Hockey Challenge and the 2019 Canadian Tire National Skating Events</u>

A Staff Report from Aaron Kennedy, Communications Manager, informed Council Hospitality Saint John recently announced the 2018 World Under-17 Hockey Challenge and the 2019 Canadian Tire National Skating Championships were named co-winners of the economic Driver of the Year Award, which is presented to an event that has been hands down an economic catalyst for our region. Both events were co-hosted by Quispamsis and Saint John. In a six month span, Mr. Kennedy wrote, these events, coupled with the Canada 55+ Games, generated an estimated \$11.5 million in economic impact in Greater Saint John.
