A Staff Report from Acting CAO Kennedy indicated the KV maps that were previously printed were not a product of Quispamsis and Rothesay. They were produced by a private business located in Saint John. Salespeople were employed to solicit ads from local KV businesses to offset the cost of production and provide a small profit to the business. Quispamsis purchased an ad - at a nominal cost - in exchange for maps that the Town made available to the public Town Hall. The maps have not been printed since 2019. Likely due to the proliferation of GPS and mapping applications available for wireless devices, the Town only gets an occasional request at Town Hall for a map. The private business has quoted a cost

of \$3,000 to prepare and print maps. At this time, Rothesay is not interested in cost-sharing maps. This item was removed from the draft budget by the Finance Committee.

Councillor Luck requested, in lieu of the Town not printing street and/or destination maps in paper form, could digital mapping be made available on the Town's website showing the Town's specific offerings, such as parks, trails, facilities, etc. to make finding such destinations more user-friendly.

Acting CAO Kennedy informed Council there is funding in this year's budget along with the proposed \$1000 for 2023 to revamp the Town's website. RFPs will be going out shortly and mapping will be considered as a component for the updated website.

Mr. Kennedy informed Council the Oldies 96 Radio is a not-for-profit community-minded KV radio station, located in Quispamsis, and has partnered with the Town on promoting the COMEX service, and has a strong relationship with the Mayor promoting Town events. They are being recommended for a \$3000 grant.
