# 2. Mayor's Comments

*Municipal Facilities* – Mayor Clark wanted to clarifying "misinformation" around the delay in reopening the Quispamsis Memorial Arena.

He noted that the pandemic has forced everyone to make difficult decisions, and Quispamsis is no exception and to avoid a deficit at the end of the year some of the Town's heavily subsidized recreation facilities have been temporarily closed. Despite many unknowns, Staff are planning for the safe reopening of the qplex, this facility was chosen to open first due to the amenities that the facility offers for a variety of residents other than ice users. Mayor Clark noted dates as follows:

- The qplex arena will open with reduced hours and staffing on Monday, Sept. 21<sup>st</sup>
- The Aquafina Walking Track, with reduced hours on September 28th
- The Moosehead Conference Centre on October 1<sup>st</sup>.
- The QMA scheduled for January 2021, could potentially open mid December.

Additional items that Mayor Clark highlighted:

- Additional ice time will be available for minor hockey at the qplex at the start of the season (as the high school and Saint John Vito's games are delayed).
- The town has added a 7 a.m. ice time Monday through Friday for high school and minor hockey.
- Staff will consider opening two hours earlier at 2 p.m. if there is demand from youth associations or other users.
- QMA will be used by Fundy Lacross until the end of November.

*Back to School* - Mayor Clark acknowledged that next week is back to school for teachers and students and reminded motorists to drive cautiously and be on the look out for pedestrians. Further noting that because of COVID-19, more parents will be opting to drive their children rather than send them on the school bus, therefore traffic congestion is expected to be increased.

*Road Construction* - Mayor Clark also reminded motorists that Alma Lane and Squire Drive remain closed as construction of the roundabout on the Gondola Point Arterial is ongoing and drivers are asked to continue to use alternate routes, such as Pettingill Road and Chamberlain Road.

Regional Economic Development - Mayor Clark announced that Qualified professionals are being invited to serve on the Board of Directors for the New Regional Economic Development Agency for Greater Saint John. Expressions of

interest will be accepted until 5pm AST, Friday, September 11, 2020. More details can be found at redagsj.com.

Further stating that Council can go on record and support of the Kings Valley Manor's application to conduct a feasibility study for such an expansion, acknowledging that the Town's Municipal Plan does promote a range of housing options, including Multiple Residential, to meet the diversified housing needs of the community.
