#### 7.1 Fascia Sign Variances - 175 Hampton Road

Mr. Bill Hart, of SMID Design Inc, attended seeking sign variances for Unit 103 - Match Box Pizza, and Unit 104 - Taco Bowl at 175 Hampton Road, PID 243204. Variances included a size variance of six decimal two (6.2) square metres from the Sign By-Law No. 036, Section 13.A.(1)a.i) for the signage on Unit 103 for Match Box Pizza, and a size variance of three decimal two (3.2) square metres for Taco Bowl in Unit 104, plus a variance of one (1) fascia sign for Unit 103 and one (1) fascia sign for Unit 104 from Section 13.A.(1) of the same by-law.

Mr. Hart stated that the Taco Bowl in McAllister Place is both eat-in and take-out business and this location will be similar with seating room of approximately twenty (20). The kitchen is shared with Match Box Pizza but the seating is separate with Match Box having seating for approximately thirty (30) people. For those residents who were fans of the Angelo's Pizza, Mr. Hart stated that the staff from Angelo's is still with the new company and they are keeping the same menu and tastes plus they are adding wings and other things. Mr. Hart addressed the balance of the three signs on Unit 104 for Taco Bowl, noting that his background studies is in photography and that he worked with the sign company to design the images so they looked to have a somewhat similar balance to other signs on the building. He also noted that the sign is the same as the one in McAllister Place, as brand name signage. While the application indicated there (3) different signs pieces, Mr. Hart stated that the Taco Bowl signage will be designed as one back drop for the top section with the round Taco Bowl words and the round logo as one piece. The menu style board that lists the main items was already in place for previous businesses and was just updated with their wording. He stated that this sign could be removed if the PAC felt it necessary.

It was discussed adding a condition to be added so the next business doesn't get the same amount of signage but recognized that they would require PAC approval as this review is only for the companies named herein.

Notice was sent to property owners in the radius of 100 metres; no concerns were received and no persons attended to speak for or against the application.
